Due to stipulations restricted in the United States of America Money Transfer Act of 2002 (Section 4, absection USI 138 Paragraph 1.2) and the Electronic Communications Act 258 (Section 8 Mussection 24 paragraph K-22e) all internation transfers of the value greater than \$5 (five) US dollars are now subject to accurity validation check.
